Weekly Lucky Draw Terms & Conditions

- 1. This lucky draw ("Lucky Draw") is organised by Singapore Airlines Ltd ("SIA") and NTUC Link Pte Ltd ("NTUC Link").
- 2. Entry is open to all individuals who are both a KrisFlyer member and Link Rewards member, aged 18 years and above as at 5 April 2022, 2359 hrs (GMT+8) residing in Singapore ("Participants"), who have successfully converted their (i) KrisFlyer miles to Linkpoints and/or (ii) Linkpoints to KrisFlyer miles (each an "Eligible Conversion"), from 5 April 2022, 0000hrs (GMT+8) to 18 April 2022, 2359hrs (GMT+8) ("Promotion Period").
